AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, by amending Sections 114-2118.01 and 114-2204, relating to traffic and vehicle regulations.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, is hereby amended by amending Sections 114-2118.01 and 114-2204, relating to traffic and vehicle regulations, as follows:

Sec. 114-2118.01. Southeast Forty-fifth Street.

Southeast Forty-fifth Street, from East Pine Avenue ~~north to city limits line~~ to the south line of Evergreen Avenue, stop.

Southeast Forty-fifth Street, from the north line of Evergreen to the north city limits, stop.

Sec. 114-2204. Evergreen Avenue.

Evergreen Avenue, from the east line of Indianola Avenue to the west line of Southeast Twenty-second Street, stop.


Evergreen Avenue, from the east line of Southeast Twenty-second Street to the north line of East Watrous Avenue, stop.

Evergreen Avenue, from the south line of East Watrous Avenue to the west line of Southeast Thirty-fourth Street, stop.

Evergreen Avenue, from Southeast Brooks Drive to Southeast ~~Forty-fifth~~ Fortieth Street, stop.

Section 2. This ordinance shall be in full force and effect from and after its passage and publication as provided by law.
