ORDINANCE NO.

AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, by amending Section 114-3579 relating to traffic and vehicle regulations.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, is hereby amended by amending Section 114-3579, relating to traffic and vehicle regulations, as follows:

Sec. 114-3579. East Pleasant View Drive-South Union Street to Southeast Seventeenth Street.

East Pleasant View Drive, on the north side, from South Union Street to Southeast Fifth Street, no parking any time.

East Pleasant View Drive, on the south side, from South Union Street to a point 100 feet east thereof, no parking any time.

East Pleasant View Drive, on the south side, from a point 505 feet east of South Union Street to a point 445 feet east thereof, no parking any time.

East Pleasant View Drive, on the south side, from a point 1095 feet west of Southeast Fifth Street to a point 380 feet east thereof, no parking any time.

East Pleasant View Drive, on the south side, from Southeast Fifth Street to a point 50 feet east thereof, no parking any time.

East Pleasant View Drive, on the north side, from Southeast Fifth Street to Southeast Eighth street, no parking any time.

East Pleasant View Drive, on the south side, from Southeast Eighth Street to Indianola Avenue, no parking any time.

East Pleasant View Drive, on the north side, from Southeast Fourteenth Street to a point 50 feet east thereof, no parking any time.

East Pleasant View Drive, on the south side, from Southeast Fourteenth Street to Southeast Seventeenth Street, no parking any time.

Section 2. This ordinance shall be in full force and effect from and after its passage and publication as provided by law.
