Scarification of existing asphalt streets, furnish and place Hot Mix Asphalt (HMA), furnish and place pavement markings, and other incidental items; in accordance with the contract documents, at the following locations: Echo Valley Drive from S.W. 42nd Street to Norwalk City Limits S.E. 1st Street – Indianola Avenue to Scott Avenue Hull Avenue – E. 14th Street to Dixon Street Guthrie Avenue – I-235 to Hubbell Avenue

WHEREAS, notice of the hearing on the plans, specifications, form of contract documents, and Engineer's estimate of construction cost was published as required by law.

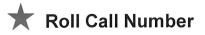

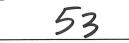
