WHEREAS, the Information Technology (IT) Department has requested the Finance Department's Procurement Division issue a purchase order for the purchase of Cisco network hardware; and

WHEREAS, the Cisco network hardware and equipment is being procured through the competitive bid process issued by the Iowa Department of Administrative Services (DAS); and

WHEREAS, Municipal Code section 2-726 (k) provides for the procurement of goods and/or services from contracts established by the State of Iowa Department of Administrative Services, the Iowa Department of Transportation, or the Iowa Communications Network pursuant to procedures established by Iowa Code Chapter 8A and rules and regulations promulgated thereunder, without conforming to the competitive bidding requirements of the Procurement Ordinance; and

WHEREAS, the purchase of Cisco network hardware for the Information Technology (IT) Department is being purchased from Heartland Business Systems, LLC, 4201 Westown Parkway, Suite 220, West Des Moines, IA 50266 (Peter Helander, CEO) via State of Iowa Contract No. 4846A, NASPO ValuePoint AR233; and

WHEREAS, funding is available from Capital Improvements Program CIP FY2019/20, MSC001, C051IT99, Miscellaneous Improvements Enhanced City-wide Information and Communication Systems, page 7, for a total amount of \$70,840.79.

NOW, THEREFORE, BE IT RESOLVED, that the City Council of the City of Des Moines, Iowa, accepts and approves the purchase of Cisco Network from Heartland Business Systems, LLC in the total amount of \$70,840.79 using pricing under the State of Iowa Contract No. 4846A, NASPO ValuePoint AR233.
