AUTHORIZING APPLICATION TO THE UNITED STATES DEPARTMENT OF AGRICULTURE FOR AN EMERGENCY WATERSHED PROTECTION PROGRAM GRANT AND AUTHORIZING CITY MANAGER TO EXECUTE APPLICATION AND CERTIFICATIONS

WHEREAS, the Public Works Department desires to apply for an Emergency Watershed Protection Program grant from the United States Department of Agriculture (USDA) requesting \$177,723.15 to help fund erosion repair and protection projects to protect public and private infrastructure within the City of Des Moines; and

WHEREAS, USDA staff have approved four project sites as eligible for the Emergency Watershed Protection Program funds; and

WHEREAS, such USDA Emergency Watershed Protection Program grant provides a 75% cost share for construction costs in addition to administrative expenses up to 7.5% of the total construction cost; and

WHEREAS, such grant application requires that the City provide certain assurances, described in the attached Assurances – Construction Programs form and the Certification Regarding Lobbying form, attached hereto, with the grant application, and that the City representative signing such grant application be duly authorized to act on the City's behalf; and

WHEREAS, it is in the best interests of the City of Des Moines to authorize the City Manager to sign and submit such grant application on behalf of the City of Des Moines.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa that the City hereby agrees to the Assurances, as provided in the attached Assurances - Construction Programs and Certification Regarding Lobbying attachment, and the City Manager is hereby authorized to sign and submit the above described application and certifications for the Emergency Watershed Protection Program grant seeking the amount of \$177,723.15 from the United States Department of Agriculture.




