AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, by amending Chapter 114 Traffic and Vehicle Regulations, by amending Sections 114-319.02, 114-319.03, 114-1427, 114-1642, 114-2105, 114-2192, 114-2907, 114-3161, and 114-3324; adding Section 114-3363.5; and repealing Sections 114-1353, 114-3017.3, and 114-3780, as summarized below. The ordinance shall be in immediate full force and effect.

DES MOINES TRAFFIC REGULATION CHANGES

Amending Chapter 114 of the Municipal Code regarding traffic regulation changes as follows:

- A. Code correction to match field conditions – Holcomb Avenue between 6th Avenue and the dead end.
- B. Code revisions related to the Hubbell Avenue Reconstruction Project – E 38th Street, E Douglas Avenue, Kennedy Drive and Hubbell Avenue.
- C. Code corrections related to speed limit and parking changes on park roads.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, is hereby amended by amending Sections 114-319.02, 114-319.03, 114-1427, 114-1642, 114-2105, 114-2192, 114-2907, 114-3161 and 114-3324, and by adding Section 114-3363.5, and by repealing Sections 114-1353, 114-3017.3 and 114-3780, relating to traffic and vehicle regulations, as follows:

Sec. 114-319.02. Locations of three-way stop intersections.

The following intersections are hereby designated as three-way intersections. Stop signs shall be installed and maintained at the following intersections and the driver of a vehicle approaching these intersections from the directions hereinafter designated shall stop in accordance with this chapter before entering these intersections:

- (1) ~~Avenue Frederick M. Hubbell and East Euclid Avenue. The driver of a vehicle approaching this intersection from the west, north and south shall stop before entering the intersection.~~ East Douglas Avenue and East Thirty-eighth Street. The driver of a vehicle approaching this intersection from the south, east and west shall stop before entering the intersection.
- (2) Pennsylvania Avenue and East Washington Avenue. The driver of a vehicle approaching this intersection from the east, north and south shall stop before entering the intersection.
- (3) County Line Road and Southeast Fifth Street. The driver of a vehicle approaching this intersection from the north, east and west shall stop before entering this intersection.
- (4) Watrous Avenue and Southwest Twenty-sixth Street. The driver of a vehicle approaching this intersection from the east, north and south shall stop before entering the intersection.
- (5) Guthrie Avenue (west) and North Union Street. The driver of a vehicle approaching this intersection from the north, south and west shall stop before entering the intersection.

- (6) Mulberry Street and Thirteenth Street. The driver of a vehicle approaching this intersection from the north, east and west shall stop before entering the intersection.
- (7) Southwest Eleventh and DART Way. The driver of a vehicle approaching this intersection from the north, south, and east shall stop before entering the intersection.
- (8) Lynner Drive and Martin Luther King Jr Parkway. The driver of a vehicle approaching this intersection from the north, south, and west shall stop before entering the intersection.
- (9) Walnut Street and Fourth Street. The driver of a vehicle approaching this intersection from the south, east and west shall stop before entering the intersection.


