

WHEREAS, the low dollar compliant bid was received from Eagle Sign Company, 605 SW 37<sup>th</sup> St, Grimes, IA 50111, John and Janis Nagle, Owners; and

WHEREAS, funding is available from C040PK99/PK137/Park Improvements in the amount of \$144,675.70 and C040PK99/PK140/Gray's Lake Park Improvements in the amount of \$14,003.36 at a total cost of \$158,679.06; and

WHEREAS, the Procurement Administrator and the Parks and Recreation Department recommend approval of the low dollar compliant bid.

NOW THEREFORE BE IT RESOLVED, that the Des Moines City Council hereby accepts and approves the award to Eagle Sign Company for sign fabrication and installation services at various City sites at a total cost of \$158,679.06.
