WHEREAS, on March 23, 2020, under Roll Call No. 20-0504, plans, specifications, form of contract documents, and Engineer's estimate of construction cost were filed with the City Engineer, for the construction of the following improvement:

E. 29th Street Rehabilitation from Easton Boulevard to Euclid Avenue, 06-2019-006 STBG-SWAP-1945(847)--SG-77

The improvement includes pavement scarification and Hot Mix Asphalt (HMA) overlay, Portland Cement Concrete (PCC) patching, PCC sidewalk, pavement markings, traffic signal modifications, and other incidental items; all in accordance with the contract documents, including Plans File Nos. 613-225/247, on E. 29th Street from Easton Boulevard to Euclid Avenue, Des Moines, Iowa.

WHEREAS, notice of the hearing on the plans, specifications, form of contract documents, and Engineer's estimate of construction cost was published as required by law.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That the hearing on the plans, specifications, form of contract documents, and Engineer's estimate of construction cost for said improvement be closed; and that said plans, specifications, form of contract documents, and Engineer's estimate of construction cost are hereby approved as the plans, specifications, form of contract documents, and Engineer's estimate of construction cost for said improvement.

BE IT FURTHER RESOLVED: That the City Council hereby authorizes the necessary road closures for the Project.
