APPROVING AN AMENDMENT TO THE SCHEDULE OF FEES APPLICABLE TO EMERGENCY MEDICAL SERVICES UNDER CHAPTER 38 OF THE MUNICIPAL CODE

WHEREAS, Chapter 38 of the Municipal Code of the City of Des Moines provides that fees for the use of emergency ambulance services provided by the City Fire Department specified in Section 38-26(a) shall be in the amounts set in a Schedule of Fees adopted by the City Council by resolution; and

WHEREAS, an amendment to the Schedule of Fees concerning the above referenced services has been prepared for Council consideration and is recommended for adoption, which amendment is appended hereto and is now on file in the office of the City Clerk.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa that the amendment to the Schedule of Fees appended hereto is hereby approved and adopted.

BE IT FURTHER RESOLVED that the City Clerk is hereby authorized and directed to incorporate said amendment into the Schedule of Fees, and to maintain said Schedule of Fees, as amended, on file in the Office of the City Clerk for public reference, and that the fees established in said amendment shall become effective July 1, 2020.
