APPROVING AN EXCEPTION TO THE PROCUREMENT ORDINANCE REQUEST FOR PROPOSALS REQUIREMENT FOR GOOD CAUSE AND APPROVING AN AMENDMENT FOR EXTENSION OF AGREEMENT WITH NESTINGEN, INC. D/B/A RELYDB FOR DATABASE ADMINISTRATIVE SERVICES

WHEREAS, the City of Des Moines Information Technology Department has an immediate and continuing need for database administrative services to support the current and future City Information Technology projects; and

WHEREAS, the skills required to perform these services are highly technical, are unique to the individual possessing such skills, and are developed over a substantial period of time; and

WHEREAS, the required skills are not currently available in the Information Technology Department; and

WHEREAS, Nestingen, Inc. d/b/a RelyDB (Carl Nestingen, President, Clive, Iowa) possesses the required skills and abilities to furnish database administration services and has provided such services to the City for approximately 20 years under separate multi-year agreements; and

WHEREAS, on June 12, 2017, by Roll Call No. 17-1002, the City Council approved an agreement with Nestingen, Inc. for such services which will expire on June 30, 2020 (the Agreement); and

WHEREAS, Nestingen, Inc. has indicated a need to reduce consulting hours after expiration of the current Agreement and its intention to end consulting services to the City by June 30, 2023, and has additionally proposed a software licensing agreement for software developed by Nestingen, Inc.; and

WHEREAS, Nestingen, Inc. and the Information Technology Department desire to extend the Agreement until September 30, 2020 in order to maintain sufficient database support while the City Information Technology Director evaluates Nestingen, Inc.'s proposal, and have negotiated an extension amendment to the Agreement in which the hours of work during the three month extension will not exceed 250 hours at an hourly rate for such services at \$140; and

WHEREAS, the City Manager and the Information Technology Director recommend that the above described procurement be exempted from the Request For Proposals requirements for good cause shown, pursuant to Section 2-710(b) of the Municipal Code of the City of Des Moines.

AMENDMENT FOR EXTENSION OF AGREEMENT FOR DATABASE ADMINISTRATIVE SERVICES BETWEEN

THIS AMENDMENT FOR EXTENSION is made as of,
2020, to the Agreement for Database Administrative Services Between City of Des
Moines, Iowa (Client) and Nestingen, Inc., d/b/a RelyDB (RelyDB) dated June26,
2017 (the "Agreement").
