AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, by amending Chapter 114, Section 2669, relating to traffic and vehicle regulations.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, is hereby amended by amending Chapter 114, Section 2669, relating to traffic and vehicle regulations, as follows:

Sec. 114-2669. Seventh Street--University Avenue Indiana Avenue to Shawnee Avenue.

Seventh Street, on the west side, from University Avenue to Indiana Avenue, no parking any time.

Seventh Street, on the east side, from Indiana Avenue to Forest Avenue, no parking any time.

Seventh Street, on the west side, from Forest Avenue to a point 40 feet south thereof, no parking any time.

Seventh Street, on the west side, from a point 210 feet north of Clark Street to College Avenue, school bus loading and unloading.

Seventh Street, on the east side, from a point 90 feet south of College Avenue to a point 25 feet south thereof, commercial loading zone.

Seventh Street, on the east side, from a point 50 feet south of Franklin Avenue to Hickman Road, no parking any time.

Seventh Street, on the west side, from a point 50 feet south of Franklin Avenue to a point 50 feet north of Franklin Avenue, no parking any time.

Seventh Street, on the west side, from New York Avenue to Corning Avenue, no parking any time.

Seventh Street, on the east side, from Corning Avenue to a point 210 feet south thereof, no parking any time.

Seventh Street, on the east side, from Boston Avenue to Ovid Avenue, no parking any time.

Seventh Street, on the east side, from Douglas Avenue to a point 375 feet south of Madison Avenue, no parking any time.

Seventh Street, on the west side, from Madison Avenue to a point 50 feet south of Madison Avenue, no parking any time.

Seventh Street, on the east side, from Madison Avenue to a point 375 feet south thereof, school passenger loading and unloading.

Seventh Street, on the east side, from Madison Avenue to Shawnee Avenue, no parking any time.

Section 2. This ordinance shall be in full force and effect from and after its passage and publication as provided by law.
