

## ORDINANCE NO.

AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, by amending Chapter 114 Sections 114-3419 and 114-3605.06, relating to traffic and vehicle regulations.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by

Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, by amending Chapter 114,

Sections 114-3419 and 114-3605.06, relating to traffic and vehicle regulations, as follows:

## Sec. 114-3419. Locust Street--Robert D Ray Drive to Second Avenue.

Locust Street, on the south side, from Robert D Ray Drive to a point 75 feet west thereof, no parking any time.

Locust Street, on the south side, from a point 214 feet east of Second Avenue to a point 39 feet west thereof, no parking any time.

Locust Street, on the north side, from a point 265 feet east of Second Avenue to a point 35 feet east thereof, commercial loading zone.

Locust Street, on the north side, from Second Avenue to a point 265 feet east thereof, no parking any time.

Locust Street, on the south side, from Second Avenue to a point 50 feet east thereof, no parking any time.

Locust Street, on the north side, from a point 185 feet west of Robert D Ray Drive to a point 505 west thereof, reserved for City of Des Moines municipal employee permit parking, 7:00 a.m. to 4:00 p.m., Monday through Friday.

## Sec. 114-3605.06. Robert D Ray Drive--East Grand Avenue to Filmore Street.

Robert D Ray Drive, on the east side, from East Grand Avenue to Des Moines Street, no parking any time.

Robert D Ray Drive, on the west side, from East Grand Avenue to a point 40 feet north thereof, no parking any time.

Robert D Ray Drive, on the west side, from a point 115 feet north of Des Moines Street to a point 45 feet north thereof, commercial loading zone.

Robert D Ray Drive, on the east side, from Des Moines Street to a point  $\frac{1,700-1,945}{1,945}$  feet north thereof, no parking any time.

Robert D Ray Drive, on the west side, from a point 280 feet north of Des Moines Street to a point 470 feet north thereof, official city vehiclesreserved for City for Des Moines municipal employee permit parking, 7:00 a.m. to 4:00 p.m., Monday through Friday.

Robert D Ray Drive, on the west side, from a point 280 feet north of Des Moines Street to a point 1,665 feet north thereof, no parking from 11:00 p.m. to 6:00 a.m.

Section 2. This ordinance shall be in full force and effect from and after its passage and publication as provided by law.
