CITY OF DES MOINES SUPPLEMENTAL AGREEMENT NO. 1 TO AGREEMENT FOR PROFESSIONAL SERVICES 6TH AVENUE STREETSCAPE PHASE 2 - UNIVERSITY AVENUE TO COLLEGE AVENUE Activity ID 01-2019-002

WHEREAS, on November 19, 2018, by Roll Call No. 18-1893, the City of Des Moines, Iowa, hereinafter referred to as the "City", and Snyder & Associates, Inc., David Moeller, President, 2727 SW Snyder Blvd., Ankeny, IA 50023, hereinafter referred to as the "Consultant", entered into a Professional Services Agreement (the Agreement) in connection with the 6th Avenue Streetscape Phase 2 - University Avenue to College Avenue, not to exceed \$464,054.00; and

WHEREAS, the City staff has negotiated a Supplemental Agreement No. 1 for additional professional services with the Consultant for construction survey and staking; and

NOW, THEREFORE, IT IS MUTUALLY AGREED, that the Agreement for Professional Services, 6th Avenue Streetscape Phase 2 - University Avenue to College Avenue is amended as follows:

SECTION 2 - SCOPE OF SERVICES, Paragraph A, SERVICES PROVIDED BY CONSULTANT, is amended by adding the following:

"Consultant shall provide additional construction survey and staking services as set forth in Attachment 1 to this Supplemental Agreement."

SECTION 3 - COMPENSATION, Paragraph A, is amended by adding the following:

"Compensation for services under this Supplemental Agreement shall be in accordance with the terms of said original Professional Services Agreement for an additional not-to-exceed amount of \$48,000 to be paid on the basis of hourly labor rates and reimbursable costs as shown in Attachment 3 to the Agreement.

SECTION 4 - COMPLETION OF WORK, is amended by adding the following:

"The Consultant shall complete all services outlined in Supplemental Agreement No. 1 on or before December 31, 2021, providing no unforeseen delays are experienced beyond the control of the Consultant."

BE IT FURTHER AGREED, that all other terms and conditions of the original November 19, 2018 Agreement shall remain in full effect except as modified by this Supplemental Agreement No. 1.

SCOPE OF SERVICES

PROFESSIONAL SERVICES FOR 6TH AVENUE STREETSCAPE PHASE 2 - UNIVERSITY AVENUE TO COLLEGE AVENUE Activity ID 01-2019-002

The Consultant shall provide construction survey and staking services for the 6th Avenue Streetscape Phase 2 project located along 6th Avenue from University Avenue to College Avenue.

TASK 1 - Construction Survey and Staking Services:

1.1

The Consultant shall provide construction survey and staking services for the project. The Consultant shall follow all Iowa Department of Transportation (IDOT) procedural requirements for project management of Federal-Aid projects, including those described in the IDOT "Instructional Memorandums to Local Public Agencies" (IM), the IDOT "Construction Manual" the IDOT Materials Instructional Memorandums, the coordinating IDOT office's standard procedures and in accordance with the survey requirements set forth in the Iowa Code. The Consultant shall complete the following tasks to verify the project is constructed in substantial conformance with the approved plans and specifications.

1.1 **Construction Survey and Staking:** The Consultant shall provide construction survey for the project and provide construction staking for use by the Contractor to construct the project in accordance with the design plans for the project.
