SET HEARING FOR APPROVAL OF DOCUMENTS FOR VACATION OF A PORTION OF ASHWORTH PARK LOCATED NORTH OF AND ADJOINING 514 FOSTER DRIVE AND APPROVAL OF A LAND EXCHANGE AGREEMENT WITH DAVID J. STEFFES AND WENDY S. STEFFES

WHEREAS, the City of Des Moines, Iowa, ("City") is the owner of certain excess parkland located in Ashworth Park and lying north of and adjoining 514 Foster Drive, Des Moines, Iowa (hereinafter "City Parcel"), more particularly described below; and

WHEREAS, David J. Steffes and Wendy S. Steffes, husband and wife, ("Seller") are the owners of certain property located at the west edge of 514 Foster Drive, Des Moines, Iowa, (hereinafter "Seller Parcel"), more particularly described below; and

WHEREAS, David J. Steffes and Wendy S. Steffes, have offered to the City of Des Moines, Iowa, the Seller Parcel in exchange for the City Parcel, described below, in order to assemble said City Parcel with their adjoining property for sideyard uses and to eliminate an existing encroachment of the driveway, subject to a reservation of easements therein; which represents an equitable exchange of value as determined by the City's Real Estate Division; and

WHEREAS, the City has no known current or anticipated public need for the City Parcel proposed to be exchanged and the City will not be inconvenienced by the vacation and conveyance of said City Parcel.
