HOLD HEARING ON DONATION AND CONCESSION AGREEMENT FOR THE RIVERVIEW PARK CONCESSION WITH PARKS AREA FOUNDATION

WHEREAS, the City Parks and Recreation Department is charged with the responsibility of providing recreational activities, including outdoor performance stages, within the City of Des Moines; and

WHEREAS, the City owns Riverview Park, located at 710 Corning Avenue, Des Moines, Iowa; and

WHEREAS, on January 22, 2018, by Roll Call No. 18-0151, the City Council approved a Donation and Concession Agreement By and Between City of Des Moines, Iowa and Parks Area Foundation for Riverview Park Stage with an initial term until January 8, 2047, with one 10 year renewal option upon mutual consent, for the consideration of 5% of annual gross revenues for sales of food, beverages, alcoholic beverages, event ticket sales, and other items with gross revenues received starting in 2021("Agreement"); and

WHEREAS, due to delays in construction of the stage and the COVID-19 pandemic, no use of the stage has occurred in 2020 and a substantially decreased use of the stage is expected in 2021 due to the expected continuation of the COVID -19 pandemic throughout at least the first half of 2021, which will result in substantially reduced income from the sale of food, beverages, alcoholic beverages, event tickets and other items; and

WHEREAS, the Parks Area Foundation ("PAF") has requested that the Agreement be amended to delay the start of the concession payments on gross revenues to begin for gross revenues received during calendar year 2022, to extend the initial term until December 31, 2038, and to add one additional 10-year renewal option; and

WHEREAS, Parks and Recreation Department staff and the PAF have negotiated an Amendment to the Agreement, a copy of which is on file in the City Clerk's Office; and

WHEREAS, on November 9, 2020, by Roll Call No. 20-1772, it was duly resolved by the City Council that the proposed Amendment to Donation and Concession Agreement be set down for hearing on November 23, 2020 at 5:00 pm in the Council Chamber; and

WHEREAS, due notice of said proposal to approve an Amendment to the donation and Concession Agreement for use of public real property interests was given as provided by law, setting forth the time and place for hearing on said proposal; and

WHEREAS, in accordance with said notice, those interested in said proposed Amendment to Donation and Concession Agreement, both for and against, have been given an opportunity to be heard with respect thereto and have presented their views to the City Council.
