## SET HEARING FOR APPROVAL OF DOCUMENTS TO CORRECT THE VACATION OF A PORTION OF COURT AVENUE RIGHT-OF-WAY LOCATED SOUTH OF AND ADJOINING 309 COURT AVENUE

**WHEREAS**, on April 27, 1992, by Roll Call No. 92-1482, the City Council of the City of Des Moines voted to pass Ordinance No. 11,805 vacating approximately 307.08 square feet of Court Avenue right-of-way located south of and adjoining 309 Court Avenue to allow for a sidewalk café lease, subject to the reservation of easements for any existing utilities until such time that they are abandoned; and

WHEREAS, on October 7, 2013, by Roll Call No. 13-1592, the City Council of the City of Des Moines voted to pass Ordinance No. 15,224 vacating an additional 287.85 square feet of Court Avenue right-of-way located south of and adjoining 309 Court Avenue to expand the sidewalk café lease area, subject to the reservation of easements for any existing utilities until such time that they are abandoned; and

**WHEREAS**, subsequent to passing Ordinance No. 11,805 and Ordinance No. 15,224 an error was discovered in the legal description of the vacated right-of-way leading to the need to repeal said ordinances and pass a new ordinance to vacate the properly described right-of-way.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Des Moines, Iowa, that:

1. The City Council of the City of Des Moines, Iowa, shall consider adoption of a corrected ordinance permanently vacating a portion of Court Avenue right-of-way located south of and adjoining 309 Court Avenue, legally described as follows, subject to the reservation of easements for any existing utilities until such time that they are abandoned:

THE NORTH 9.5 FEET OF THE COURT AVENUE RIGHT OF WAY LYING SOUTH OF AND ADJOINING LOT 7, BLOCK 24, FORT DES MOINES, AN OFFICIAL PLAT; AND THE NORTH 9.5 FEET OF THE COURT AVENUE RIGHT OF WAY LYING SOUTH OF AND ADJOINING THE WEST 1 FOOT OF LOT 8 IN SAID BLOCK 24; ALL NOW INCLUDED IN AND FORMING A PART OF THE CITY OF DES MOINES, POLK COUNTY, IOWA, AND CONTAINING APPROXIMATELY 636.5 SQUARE FEET.

2. That the meeting of the City Council at which the repeal of Ordinance No. 11,805 and Ordinance No. 15,224 and the adoption of said corrected ordinance vacating such right-of-way is to be considered shall be on December 21, 2020, said meeting to be held at 5:00 p.m., in the City Council Chamber, Richard A. Clark Municipal Service Center, 1551 E. Martin Luther King Jr. Parkway, Des Moines, Iowa. Given Mayor Cownie's March 17, 2020 Proclamation, as amended, prohibiting indoor gatherings of ten or more persons on public property, Section One of the Governor's October 16, 2020 Proclamation strongly encouraging vulnerable Iowans to limit participation in gatherings of any size and any purpose during the COVID19 outbreak, and further given Section 109 of the Governor's October 16, 2020 Proclamation suspending the regulatory provisions of Iowa Code §§ 21.8, 26.12,
