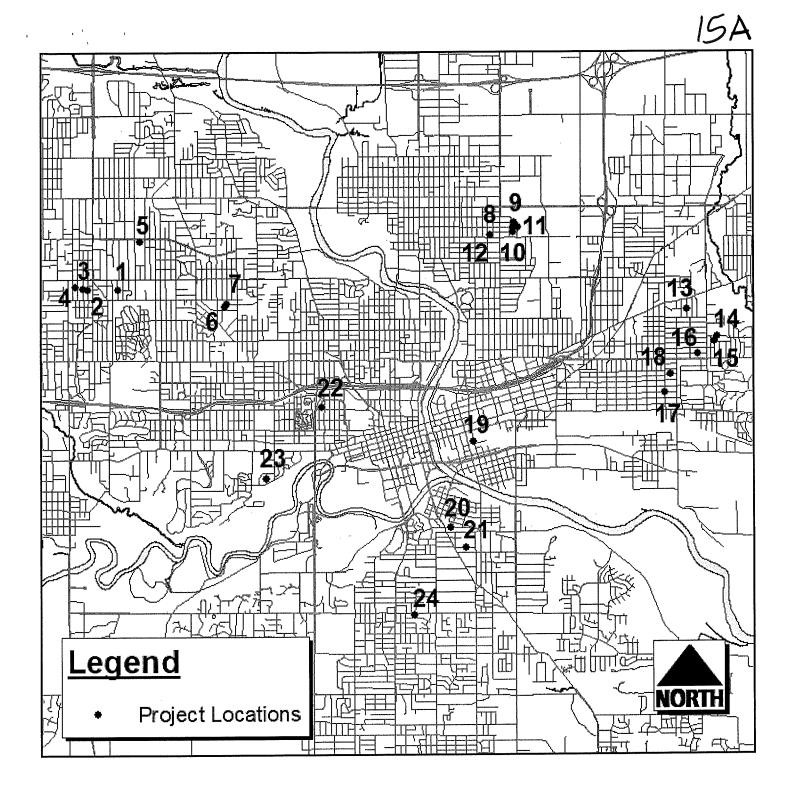

#### **CERTIFICATION OF COMPLETION:**

On July 15, 2019, under Roll Call No. 19-1160, the City Council awarded a contract to Grimes Asphalt and Paving Corporation, Timothy Mallicoat, President, 5550 NE 22nd Street, Des Moines, IA 50313 for the construction of the following improvement:

#### 2019 Residential Paving, 062019016

Removal of existing Hot Mix Asphalt (HMA) pavement and surfacing materials by milling/scarifying to an average depth of four-inches, preparing subgrade/subbase, and reconstructing four-inches HMA pavement with two equal lifts, and replacing existing sidewalk ramps with ADA-compliant ramps as directed by the engineer at the following sites:

53rd Street from Franklin Avenue to Hickman Road 59th Street from Franklin Avenue to Francis Avenue Lincoln Avenue from 59th Street to 61st Street Francis Avenue from 61st Street to 62nd Street 49th Place from Urbandale Avenue south to dead-end Nierob Court from Washington Avenue north to dead-end 36th Street from Washington Avenue to Franklin Avenue E.
