AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, by amending Sections 114-1339, 114-2297, 114-3486, 114-3486.2, 114-3486.1, 114-3486.001, 114-3486.05, and adding Sections 114-2960.5, relating to traffic and vehicle regulations.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, by amending Sections 114-1339, 114-2297, 114-3486, 114-3486.2, 114-3486.1, 114-3486.001, 114-3486.05, and adding Sections 114-2960.5, relating to traffic and vehicle regulations, as follows:

### Sec. 114-1339. Southwest McKinley Avenue.

Southwest McKinley Avenue, from Southwest Forty-second Street to Southwest Forty-sixth Street, 45 miles per hour.

Southwest McKinley Avenue, from Southwest Forty-sixth Street to a point 1,000 feet east of Iowa Highway 28, 35 miles per hour.

Southwest McKinley Avenue, from a point 1,000 feet east of Iowa Highway 28 to Iowa Highway 28, 30 miles per hour.

#### Sec. 114-2297. Oak Park Avenue.

Oak Park Avenue, at Eighth Street, stop.

Oak Park Avenue, at Eleventh Street, stop.

Oak Park Avenue, at Fourteenth Street, stop.

Oak Park Avenue, at York Street, stop.

Oak Park Avenue, at Ravina Drive, stop.

## Sec. 114-2960.5. Southwest Sixty-first Street—Gordon Avenue to Southwest McKinley Drive.
