## SETTING DATE OF HEARING ON AMENDMENT TO MUNICIPAL HOUSING AGENCY ANNUAL BUDGET FOR THE CURRENT FISCAL YEAR ENDING JUNE 30, 2021

WHEREAS, an amendment to the Municipal Housing Agency's annual budget for the current fiscal year ending June 30, 2021 is necessary to reflect changing estimates of revenue and expenditure appropriations relating to cash on hand at the end of the preceding fiscal year; amounts available from revenues and adjustments in expenditures across all programs; and transfers between funds and between programs.

NOW, THEREFORE, BE IT RESOLVED by the Municipal Housing Governing Board that:

- 1. The public hearing on the Amendment to the Municipal Housing Agency's annual budget for the fiscal year ending June 30, 2021 is hereby set for the 8th day of March, 2021 at 4:15 o'clock p.m. in the in the 2<sup>nd</sup> Floor, MSC Board Room, Richard A. Clark Municipal Services Center, Des Moines, Iowa, at which time any resident or taxpayer of the City or the area of operation of the Agency may present objections to any part of the proposed budget amendment and change or arguments in favor of any part of the proposed budget amendment or change.
- 2. The City Clerk is hereby authorized and directed to publish notice of the hearing in the attached form in the Des Moines Register, a newspaper of general circulation in the City of Des Moines, Polk County, Iowa, in accordance with Iowa Code Section 362.3 not less than ten (10) nor more than twenty (20) days prior to the date set for hearing.
