HEARING AND ADOPTION OF PROPOSED MUNICIPAL HOUSING AGENCY ANNUAL BUDGET FOR THE FISCAL YEAR ENDING JUNE 30, 2022

WHEREAS, on February 22, 2021, by Roll Call No. 21-0239, the Municipal Housing Governing Board set the public hearing to consider the Municipal Housing Agency’s proposed annual budget for the fiscal year ending June 30, 2022 for March 8, 2021 at 4:15 p.m. in the Richard A. Clark Municipal Services Center at 1551 East Martin Luther King Jr. Parkway and public notice of such hearing was published as provided by law in the Des Moines Register on February 24, 2021; and

WHEREAS, those residents and taxpayers of the City or the area of operation of the Agency interested in the Municipal Housing Agency’s proposed annual budget for the fiscal year ending June 30, 2022, have been given an opportunity to present to the Municipal Housing Governing Board objections to any part of the budget and arguments in favor of any part of the budget at this public hearing.

NOW, THEREFORE, BE IT RESOLVED by the Municipal Housing Governing Board that:

1. The publication of notice for the hearing on February 24, 2021 is hereby ratified.
2. Upon due consideration of all views and comments presented by residents and taxpayers of the City or the area of operation of the Agency, the public hearing on the Municipal Housing Agency’s proposed annual budget for fiscal year ending June 30, 2022 is hereby closed.
3. The Municipal Housing Agency’s annual budget for the fiscal year ending June 30, 2022, as set forth in the operating budget document on file with the City Clerk is hereby approved and adopted.
4. The Mayor and City Clerk are hereby directed to execute and to certify the Municipal Housing Agency’s budget for the fiscal year ending June 30, 2022 to the Des Moines City Council for incorporation into the City’s fiscal year 2022 budget to be certified to the State of Iowa.
