ORDINANCE NO.	

AN ORDINANCE vacating air rights and subsurface rights in portions of 6th Avenue right-of-way adjoining 1230 6th Avenue, Des Moines, Iowa.

WHEREAS, all prior requirements of law pertaining to the vacation of public right-of-way have been fully observed; and

WHEREAS, it is desirable that the public right-of-way herein described be vacated;

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Des Moines, Iowa:

Sec. 1. That a portion vacating air rights and subsurface rights in portions of 6th Avenue right-of-way adjoining 1230 6th Avenue, Des Moines, Iowa, more specifically described as follows, be and are hereby vacated:

Air Rights

A PART OF LOTS 35 THROUGH LOT 38, GRAND PARK, AN OFFICIAL PLAT AND A PART OF THE RIGHT OF WAY OF 6TH AVENUE, NOW INCLUDED IN AND FORMING A PART OF THE CITY OF DES MOINES, POLK COUNTY, IOWA AND MORE PARTICULARLY DESCRIBED AS FOLLOWS:




