ACCEPTANCE OF PROPOSAL WITH MIDAMERICAN ENERGY COMPANY TO INSTALL NEW LED STREETLIGHTS FOR THE HUBBELL AVENUE RECONSTRUCTION FROM E. EUCLID AVENUE TO EAST OF E. 38th STREET, ESTIMATED AT \$177,956.30

WHEREAS, reconstruction of Hubbell Avenue from E. Euclid Avenue to east of E. 38th Street requires installation of new streets lighting; and

WHEREAS, MidAmerican Energy Company has submitted a proposal to the City to install new galvanized poles with LED fixtures and underground wiring for Hubbell Avenue Reconstruction; and

WHEREAS, compensation will be based on actual costs, which costs are estimated at \$177,956.30.


NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA:

- 1. That the proposal from MidAmerican Energy Company to the City of Des Moines for installation of street lighting for Hubbell Avenue Reconstruction, a copy of which is now on file in the office of the City Clerk, is hereby approved as to form and content.
- 2. That the Mayor is hereby authorized and directed to accept the proposal by signing it for and on behalf of the City of Des Moines, Iowa.
- 3. That the Engineering Department is authorized to administer the terms specified in the proposal.
- 4. That the Finance Director is authorized to make payment to MidAmerican Energy Company for actual costs upon receipt of an invoice acceptable to the Engineering Department.
