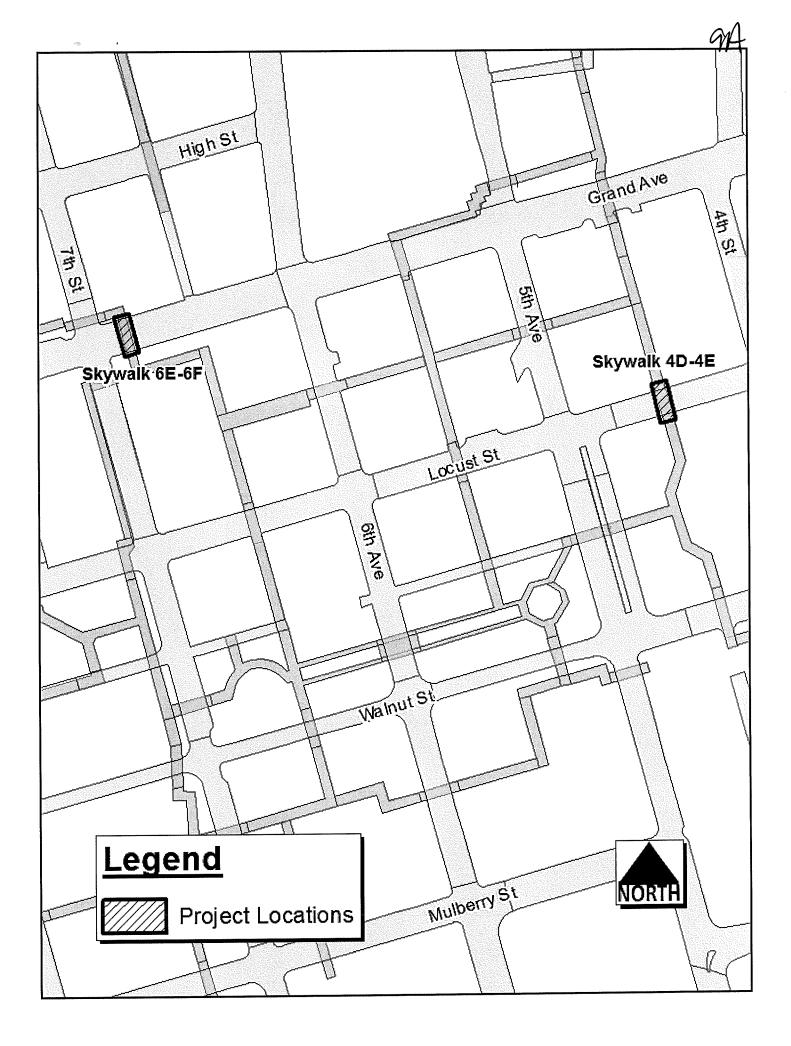

CERTIFICATION OF COMPLETION:

On June 3, 2019, under Roll Call No. 19-0939, the City Council awarded a contract to Air-Con Mechanical Corporation, James M. Shaffer, President, 3121 S.E. 14th Street, Des Moines, IA 50320 for the construction of the following improvement:

Skywalk HVAC Replacement Phase 3, 042019001

The improvement includes the removal of existing heating ventilation and air conditioning (HVAC) units and installation of two new HVAC units, electrical connections, structural modifications, screen wall installation, hand rail installation, roof repair, ceiling tile and carpet replacement, and traffic control; all in accordance with the contract documents, including Plan File Nos. 608-231/242, located at Skywalk bridges identified as 4D-4E (located in the vicinity of 5th Avenue & Locust Street), and 6E-6F (located in the vicinity of 7th Street & Grand Avenue) in downtown Des Moines, Iowa

I hereby certify that the construction of said Skywalk HVAC Replacement Phase 3, Activity ID 042019001, has been completed in substantial compliance with the terms of said contract, and I hereby recommend that the work be accepted. The work commenced on September 16, 2019, and was completed on March 22, 2021.
