WHEREAS, the Fleet Services Division has requested the Finance Department's Procurement Division issue a purchase order for the purchase of a one (1) replacement stump cutter for use in the Forestry Division of the Department of Public Works; and

WHEREAS, the replacement of the stump cutter has been approved by the Fleet Oversight Committee (FOC); and

WHEREAS, Municipal Code section 2-726 (m) provides for the procurement of goods and/or services from contracts that have been competitively established through cooperative group contracting consortiums for state government departments, institutions, agencies and political subdivisions, without conforming to the competitive bidding requirements of the Procurement Ordinance; and

WHEREAS, the replacement stump cutter is being purchased from Vermeer Sales and Service Inc., 661 Highway T14, Pella, IA, 50219, (Jason Andringa, President and CEO), in the amount of \$64,493.00 utilizing Sourcewell Contract #062117-VRM; and

WHEREAS, funding is available from the FY22 Operating Budget, Equipment Replacement Fund, page 81.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Des Moines, Iowa, accepts and approves the purchase of one (1) replacement stump cutter for the Forestry Division from Vermeer Sales and Service Inc. in the amount of \$64,493.00, utilizing Sourcewell Contract #062117-VRM.
