WHEREAS, Polk County will gift the City with funds to be used for repair of monuments in Woodland Cemetery; and

WHEREAS, the Parks and Recreation Department requested the Finance Department Procurement Division to solicit bids for monument repair services at Woodland Cemetery in order to maintain the appearance of Woodland Cemetery and to prevent negative impacts on the marketability of all Municipal Cemeteries; and

WHEREAS, the Procurement Division solicited bids by advertisement and mailing Request for Bid D21-234 to seven (7) potential bidders with one (1) bid received; and

WHERAS, the low dollar compliant bid was received from Curt Heisinger Monument Restoration, 6410 Wade Road, Jefferson City, MO 65109, Curt Heisinger, President, at a total cost of \$85,000.00; and

WHEREAS, funding in the amount of \$22,000.00 is available from CO40PK99/PK138; CIP/Cemetery Infrastructure Improvements, with the remainder of costs (\$63,000.00) to be paid from the Polk County donated funds; and

WHEREAS, the Procurement Administrator and the Parks and Recreation Department recommend approval of the low dollar compliant bid.

NOW, THEREFORE, BE IT RESOLVED, that the Des Moines City Council hereby accepts and approves the low dollar compliant bid for monument repair services at Woodland Cemetery as submitted by Curt Heisinger Monument Restoration at a total cost of \$85,000.00.
