SET HEARING FOR APPROVAL OF DOCUMENTS FOR VACATION OF A PORTION OF 23RD STREET RIGHT-OF-WAY ADJOINING WOODLAND CEMETERY

WHEREAS, on August 22, 2016, by Roll Call No. 16-1397, the City Council of the City of Des Moines authorized the acquisition of property interests for the Near West Side Sewer Separation Project; and

WHEREAS, the City's Engineering Department has determined that a dead-end portion of 23rd Street right-of-way located north of and adjoining Woodland Cemetery is required for the Project for construction and placement of a stormwater pump station; and

WHEREAS, the City's Traffic Engineer has determined that there is no known current or future public need or benefit for the right-of-way proposed to be vacated and the City will not be inconvenienced by the vacation of said right-of-way, subject to the reservation of any necessary easements for all existing utilities in place until such time as they may be abandoned or relocated.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa:

1. That the City Council of the City of Des Moines, Iowa, shall consider adoption of an ordinance permanently vacating a dead-end portion of 23rd Street right-of-way located north of and adjoining Woodland Cemetery, Des Moines, Iowa, legally described as follows, for construction and placement of a stormwater pump station for the Near West Side Sewer Separation Project, subject to the reservation of any necessary easements for all existing utilities in place until such time as they may be abandoned or relocated:

<u>Legal Description</u>

THE EAST 20 FEET OF 23RD STREET RIGHT OF WAY LYING WEST OF AND ADJOINING THE SOUTH 20 FEET OF LOT 5, KNUDSON'S ADDITION, AN OFFICIAL PLAT, ALL NOW INCLUDED IN AND FORMING A PART OF THE CITY OF DES MOINES, POLK COUNTY, IOWA, AND CONTAINING APPROXIMATELY 400 SQUARE FEET.

2. A public hearing shall be held on June 28, 2021, at 5:00 p.m. in the City Council Chamber, City Hall, 400 Robert D. Ray Drive, Des Moines, Iowa. At that time the City Council will consider the above-described proposed vacation of said street right-of-way and adoption of said ordinance and any other(s) submitted prior to or during the public hearing.


