WHEREAS, the Information Technology (IT) Department has requested the Finance Department's Procurement Division issue a purchase order for approval of the purchase of HPE backup storage hardware and Veeam backup and replication software license upgrade from OneNeck IT Solutions in the amount of \$226,741.62; and

WHEREAS, this purchase will allow the Information Technology (IT) Department to move forward with the necessary storage and software upgrades that are essential to address data growth and security needs for the City's data backup infrastructure; and

WHEREAS, this purchase is being procured through the competitive bid process using the State of Iowa contract #16091D and NASPO Value Point Contract #MNNVP-134; and

WHEREAS, Municipal Code section 2-726 (m) provides for the procurement of goods and/or services from contracts that have been competitively established through cooperative group contracting consortiums for state government departments, institutions, agencies and political subdivisions, without conforming to the competitive bidding requirements of the Procurement Ordinance; and

WHEREAS, the purchase of HPE backup storage hardware, Veeam backup and replication software license upgrade for the Information Technology (IT) Department is being purchased from OneNeck IT Solutions, 11191 Aurora Avenue, Urbandale, IA 50323, Terry Swanson (President and Chief Executive Officer); and

WHEREAS, funding is available in CIP FY2020/21-2025/26, MS001, C051IT99, Miscellaneous Improvements Enhanced City-wide Information and Communication Systems, page 7.

NOW, THEREFORE, BE IT RESOLVED, that the City Council of the City of Des Moines, Iowa, accepts and approves the purchase of HPE backup storage hardware and Veeam backup and replication software license upgrade from OneNeck IT Solutions in the total amount of \$226,741.62 using the State of Iowa contract #16091D and NASPO Value Point Contract #MNNVP-134, and the Chief Information Officer is authorized and directed to execute necessary implementing licenses or agreements, subject to approval as to form by the Legal Department.
