## RESOLUTION OF SUPPORT FOR A WORKFORCE HOUSING TAX CREDIT BENEFIT APPLICATION TO BE SUBMITTED TO THE IOWA ECONOMIC DEVELOPMENT AUTHORITY BY EUCLID FORESIGHT, LLC (CONNOR DELANY) FOR THE FRENCH WAY CLEANERS PROJECT AT 413 EUCLID AVENUE

WHEREAS, Euclid Foresight (the "Developer"), represented by Connor Delany (officer), has requested City support for its application to the Iowa Economic Development Authority ("IEDA") for State tax incentives under the Workforce Housing Tax Credit Program for the French Way Cleaners Project (the "Project"); and

WHEREAS, successful completion of the Project requires funding from a number of sources, including an award of Iowa Workforce Housing Tax Credits in the amount of \$52,800; and

WHEREAS, the application requirements for the Workforce Housing Tax Credit program include a requirement for the submission of a resolution in support of the Project by the community where the Project will be located, which requirement is intended to be satisfied by this roll call and resolution; and

WHEREAS, a further application requirement for the Workforce Housing Tax Credit program is documentation of local matching funds pledged for the project in an amount not less than \$60,810; and

WHEREAS, the Developer is proposing to undertake rehabilitation of four housing units at 413 Euclid Avenue, in the former French Way Cleaners historical building, at an estimated project cost of \$3,374,238, including \$550,000 in residential costs; and

WHEREAS, the Project is located within the City-wide Urban Revitalization Area and provided that the improvements are completed as planned and a proper application is filed, the taxable value added to the property by the completion of the improvements will qualify for tax abatement under the ten-year declining abatement schedule, providing financial assistance of approximately \$60,810 based upon the estimated annual abated property taxes.

**NOW THEREFORE, BE IT RESOLVED**, by the City Council of the City of Des Moines, Iowa, as follows:

- 1. The City Council of the City of Des Moines does hereby express its strong support for the application by Developer, to the IEDA in June 2021, seeking an award of Workforce Housing Tax Credit benefits in the amount of \$52,800.
- 2. The Mayor and the City Manager are hereby authorized and directed to sign any forms required by the Administrative Rules of the IEDA to evidence the City's support for the
