## SET HEARING FOR APPROVAL OF DOCUMENTS FOR CONVEYANCE OF A PERMANENT GAS EASEMENT ON CITY-OWNED PROPERTY LOCATED AT 101 EAST 2<sup>ND</sup> STREET TO MIDAMERICAN ENERGY COMPANY FOR THE E. 2<sup>ND</sup> STREET RECONSTRUCTION – COURT AVENUE TO IOWA INTERSTATE RAILROAD PROJECT

WHEREAS, MidAmerican Energy Company has been asked by the City of Des Moines to relocate existing gas line structures for the E. 2<sup>nd</sup> Street Reconstruction – Court Avenue to Iowa Interstate Railroad Project; and

The City Council of the City of Des Moines, Iowa proposes to grant a Permanent Gas Easement to MidAmerican Energy Company across a portion of excess City property adjoining 101 East 2<sup>nd</sup> Street in order to accommodate the relocation of the vent pipe due to a City construction project, more specifically described below, for \$1:

## **DESCRIPTION OF EASEMENT AREA:**

The South Five (5) Feet of the North Eleven (11) feet of the West Three (3) feet of Lot 2 in Block "I", in Scott and Dean's Addition to Fort Des Moines, an official Plat now included in and forming a part of the City of Des Moines, Polk County, Iowa.
