RESOLUTION SETTING DATE OF PUBLIC HEARING ON THE PROPOSED THIRD AMENDMENT TO THE URBAN RENEWAL PLAN FOR THE FLEUR DRIVE COMMERCIAL URBAN RENEWAL AREA

- 3. The Urban Design Review Board is hereby requested to provide a written recommendation on the proposed Third Amendment to be received prior to the date of public hearing.
