Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, by amending Sections 114-1277, 114-1368, 114-1368.01, 114-2644, 114-2665, 114-2679, 114-2705, 114-2713, 114-2728, 114-2750, 114-2767, 114-3115, 114-3249, 114-3258, and 114-3586, relating to traffic and vehicle regulations, as follows:

Sec. 114-1277. East Forty-second Street.

East Forty-second Street, from Williams Court to East Sheridan Avenue, 30 miles per hour. East Forty-second Street, from Boyd Avenue to Avenue Frederick M. Hubbell, 30 miles per hour.

Sec. 114-1368. Williams Street.

Williams Street, from Dean Avenue to Williams Court, 30 miles per hour.

Sec. 114-1368.01. Williams Court.

Williams Court, from Williams Street to East Forty-second Street, 30 miles per hour.

Sec. 114-2644. Sixth Avenue--High Street to Watson Powell Jr Way.

Sixth Avenue, on the east side, from High Street to a point 70 feet north thereof, no parking 7:00 a.m. to 9:00 a.m. and 4:00 p.m. to 6:00 p.m.

Sixth Avenue, on the west side, from High Street to a point 30 feet south of Watson Powell Jr Way, no parking 4:00 p.m. to 6:00 p.m.

Seventh Street, on the east side, from a point 92 feet north of Grand Avenue to High Street, no parking any time.

Seventh Street, on the west side, from Grand Avenue to High Street, no parking any time.

Sec. 114-2679. Eighth Street--Grand Avenue to High Street.

Eighth Street, on the east side, from High Street to a point 50 feet south thereof, no parking any time.

Eighth Street, on the east side, from Grand Avenue to a point 50 feet south of High Street, no parking 7:00 a.m. to 9:00 a.m.

Eighth Street, on the east side, from Grand Avenue to a point 50 feet south of High Street, no parking 4:00 p.m. to 6:00 p.m.

Eighth Street, on the west side, from Grand Avenue to a point 100 feet north thereof, no parking any time.

Eighth Street, on the west side, from a point 110 feet north of Grand Avenue to High Street, no parking 7:00 a.m. to 9:00 a.m. and 4:00 p.m. to 6:00 p.m.

Sec. 114-2705. Tenth Street--Locust Street to Grand Avenue.

Fourteenth Street, on the east side, from Linden Street to Ingersoll Avenue, no parking any time.

Fourteenth Street, on the west side, from Linden Avenue to a point 120 feet north thereof, no parking 10:00 p.m. to 7:00 a.m.

Fourteenth Street, on the west side, from Ingersoll Avenue to a point 120 feet north of Linden Street, no parking any time.

Sec. 114-2767. Sixteenth Street--West Martin Luther King Jr Parkway to High Street.

Sixteenth Street, on the west side, from West Martin Luther King Jr Parkway to Locust Street, no parking any time.

Sixteenth Street, on the east side from West Martin Luther King Jr Parkway to a point 100 feet north of Fifteenth Street, no parking any time.

Sixteenth Street, on the east side, from a point 25 feet north of Walnut Street to a point 15 feet south of Walnut Street, no parking any time.

Sixteenth Street, on the east side, from a point 122 feet north of Walnut Street to a point 80 feet north thereof, no parking any time.

Sixteenth Street, on the east side, from Locust Street to a point 10 feet south thereof, no parking any time.

Sixteenth Street, on the west side, from Grand Avenue to a point 30 feet north thereof, no parking any time.

Sixteenth Street, on the east side, from Grand Avenue to a point 50 feet north thereof, no parking any time.

Sixteenth Street, on the west side, from Ingersoll Avenue to a point 60 feet south thereof, no parking any time.

Sixteenth Street, on the east side, from Ingersoll Avenue to a point 75 feet south thereof, no parking any time.

Sixteenth Street, on the west side, from High Street to a point 130 feet south thereof, no parking any time.

Sixteenth Street, on the east side, from High Street to Linden Street, no parking any time.

Sec. 114-3115. East Court Avenue--Water Street to East Second Street.

East Court Avenue, on the north side, from Water Street to a point 95 feet east thereof, no parking any time.

East Court Street, on the south side, 85 feet east of Water Street to a point 60 feet east thereof, is designated a handicapped parking area and is subject to the same prohibition as is found in subsection 114-616(a) of this chapter.

East Court Avenue, on the north side, from East First Street to a point 65 feet west thereof, no parking any time.

East Court Street, on the south side, 80 feet west of East First Street to a point 95 feet west thereof, is designated a handicapped parking area and is subject to the same prohibition as is found in subsection 114-616(a) of this chapter.

East Court Avenue, on the south side, from East First Street to a point 35 feet east thereof, no parking any time.

East Court Avenue, on the south side, from a point 35 feet east of East First Street to a point 45 feet east thereof, loading zone, 20 minute limit.

East Court Avenue, on the south side of the street, from a point 80 feet east of East First Street to a point 50 feet west of East Second Street, back-in angle parking only, parking reserved for official police vehicles only.

East Court Avenue, on the north side, from a point 120 feet east of East First Street to a point 90 feet east thereof, loading zone.

East Court Avenue, on the south side, from East Second Street to a point 50 feet west thereof, no parking any time.

East Court Avenue, on the north side, from East First Street to a point 120 feet east thereof, marked police vehicle parking only.

East Court Avenue, on the north side, from a point 210 feet east of East First Street to East Second Street, marked police vehicle parking only.

Sec. 114-3249. Grand Avenue-Sixth Avenue to Seventh Street.

Grand Avenue, on the south side, from Seventh Street to a point 145 feet east thereof, no parking any time.

Grand Avenue, on the north side, from Seventh Street to a point 15 feet east thereof, no parking any time.

Sec. 114-3258. Grand Avenue--Fifteenth Street to Seventeenth Street.

Grand Avenue, on the south side, from a point 270 feet west of Fifteenth Street to a point 100 feet west thereof, no parking any time.

Grand Avenue, on the north side, from Fifteenth Street to a point 30 feet west thereof, no parking any time.

Grand Avenue, on the north side, from 30 feet west of Fifteenth Street to a point 70 feet west thereof, loading zone.

Grand Avenue, on the north side, from Sixteenth Street to a point 30 feet west thereof, no parking any time.

Grand Avenue, on the north side, from a point 180 feet west of Sixteenth Street to Seventeenth Street, no parking any time.

Sec. 114-3586. Raccoon Street-- Southeast Second Street to Scott Avenue.

Raccoon Street, on both sides, from Southeast Second Street to Southeast Fourth Street, no parking any time.

Raccoon Street, on the north side, from Southeast Fifth Street to and including the cul-desac at Southeast Twelfth Street, no parking any time.

Raccoon Street, on the south side, from Southeast Fifth Street to a point 50 feet east thereof, no parking any time.

Raccoon Street, on the north side, from a point 90 feet east of Southeast Eighth Street to a point 50 feet east thereof, loading zone.

Raccoon Street, on the south side, from Southeast Fifteenth Court to Southeast Sixteenth Street, no parking any time.

Raccoon Street, on the north side, from Southeast Eighteenth Street to Southeast Nineteenth Street, no parking any time.

Raccoon Street, on the south side, from Southeast Twenty-sixth Street to a point 35 feet east of Southeast Thirtieth Street, no parking any time.

Raccoon Street, on the north side, from a point 35 feet west of Southeast Thirtieth Street to Scott Avenue, no parking any time.
