ORDINANCE NO.

AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, by amending Sections 114-2608, 114-2663, 114-2664 and 114-2667, relating to traffic and vehicle regulations.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by

Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, by amending Sections 114-

2608, 114-2663, 114-2664 and 114-2667, relating to traffic and vehicle regulations, as follows:

Sec. 114-2608. Third Street--Watson Powell Jr Way to School Street.

Third Street, on the west side, from Watson Powell Jr Way to Park Street, no parking any time.

Third Street, on the west side, from Park Street to a point 100 feet north thereof, no parking any time.

Third Street, on the west side, from a point 100 feet north of Park Street to a point 140 feet north thereof, passenger loading and unloading only, 20 minute limit, 9:00 a.m. to 7:00 a.m.

Third Street, on the west side, from a point 100 feet north of Park Street to a point 140 feet north thereof, no parking 7:00 a.m. to 9:00 a.m.

Third Street, on the west side, from a point 240 feet north of Park Street to a point 35 feet north thereof, taxicab stand.

Third Street, on the west side, from a point 275 feet north of Park Street to Center Street, no stopping or standing any time.

Third Street, on the west side, from Center Street to a point 570 feet south of Crocker Street, no stopping or standing any time.

Third Street, on the west side, from a point 110 feet south of Crocker Street to a point 460 feet south thereof, passenger loading and unloading only, 20 minute limit, 9:00 a.m. to 7:00 a.m.

Third Street, on the west side, from a point 110 feet south of Crocker Street to a point 460 feet south thereof, no parking 7:00 a.m. to 9:00 a.m.

Third Street, on the west side, from School Street to a point 110 feet south of Crocker Street, no parking any time.

Third Street, on the east side, from Watson Powell Jr Way to a point 65 feet north thereof, no parking any time.

Third Street, on the east side, from a point 65 feet north of Watson Powell Jr Way to a point 135 feet south of Center Street, no parking 7:00 a.m. to 9:00 a.m.

Third Street, on the east side, from Center Street to Park Street, no parking any time.

Third Street, on the east side, from Center Street to a point 120 feet north thereof, no parking any time.

Third Street, on the east side, from a point 120 feet north of Center Street to a point 150 feet north thereof, passenger loading and unloading only, 20 minute limit, 9:00 a.m. to 7:00 a.m.

Third Street, on the east side, from a point 270 feet north of Center Street to School Street, no parking any time.

Sec. 114-2663. Seventh Street--Walnut Street to Locust Street.

Seventh Street, on the west side, from a point 62 feet south of Locust Street to a point 50 feet south thereof, loading zone.

Seventh Street, on the west side, from a point 112 feet south of Locust Street to a point 51 feet south thereof, no parking any time.

Seventh Street, on the west side, from a point 163 feet south of Locust Street to Walnut Street, no parking any time.

Seventh Street, on the east side, from to a point 115 feet south of Locust Street to a point 30 feet south thereof, commercial loading zone.

Seventh Street, on the east side, from a point 145 feet south of Locust Street to a point 45 feet south thereof, no parking any time.

Seventh Street, on the east side, from a point 190 feet south of Locust Street to a point 40 feet north of Walnut Street, commercial loading zone.

Sec. 114-2664. Seventh Street--Locust Street to Grand Avenue.

Seventh Street, on the east side, from Locust Street to Grand Avenue, no parking 7:00 a.m. to 6:00 p.m., Monday through Saturday.

Seventh Street, on the west side, from Locust Street to a point 50 feet north thereof, no parking any time.

Seventh Street, on the west side, from Grand Avenue to 95 feet south thereof, no parking any time.

Sec. 114-2667. Seventh Street--Watson Powell Jr Way to Park Street.

Seventh Street, on the west side, from a point 80 feet north of Watson Powell Jr Way to a point 80 feet north thereof, no parking any time.

Seventh Street, on the east side, from Watson Powell Jr Way to a point 50 feet north thereof, no parking any time.

Seventh Street, on the east side, from a point 50 feet north of Watson Powell Jr Way to a point 30 feet north thereof, commercial loading zone.

Section 2. This ordinance shall be in full force and effect from and after its passage and

publication as provided by law.
