AN ORDINANCE to amend the Official Zoning Map of the City of Des Moines, Iowa, set forth in Section 134-1.10 of the Municipal Code of the City of Des Moines, Iowa, 2000, by rezoning and changing the district classification of certain property located at 2400 East County Line Road (along the North side of East County Line Road in Warren County) from 'N2b' Neighborhood District to 'EX' Mixed Use District classification.

Be It Ordained by the City Council of the City of Des Moines, Iowa:
Section 1. That the Official Zoning Map of the City of Des Moines, Iowa, set forth in Section 134-1.10 of the Municipal Code of the City of Des Moines, Iowa, 2000, be and the same is hereby amended by rezoning and changing the district classification of certain property located in the vicinity of at 2400 East County Line Road (along the North side of East County Line Road in Warren County) from 'N2b' Neighborhood District to 'EX' Mixed Use District, more fully described as follows:
