**SET HEARING FOR APPROVAL OF DOCUMENTS FOR CONVEYANCE OF
VACATED CITY ALLEY RIGHT-OF-WAY LOCATED EAST OF AND ADJOINING 915
23RD STREET TO MARIA RODRIGUEZ FOR \$25**

WHEREAS, on January 2, 1979, by Roll Call No. 6301, the City Council of the City of Des Moines, Iowa passed Ordinance No. 9517 vacating the alley right-of-way located south of Olive Street, north of Rollins Avenue and west of Woodland Cemetery, including that portion located east of and adjoining 915 23rd Street, Des Moines, Iowa; and

WHEREAS, Maria Rodriguez, owner of 915 23rd Street, has offered to the City of Des Moines (“City”) the purchase price of \$25.00 for the purchase of the vacated north/south alley right-of-way located east of and adjoining 915 23rd Street (hereinafter “Property”), for assemblage with 915 23rd Street, subject to the reservation of any necessary easements for all existing utilities in place until such time that they are abandoned or relocated, which price reflects the fair market value of the City Property as determined by the City’s Real Estate Division; and

WHEREAS, there is no known current or future public need or benefit for the City Property proposed to be sold, and the City will not be inconvenienced by the sale of said Property.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, as follows:

1. The City Council of the City of Des Moines, Iowa, proposes to sell the vacated north/south alley right-of-way located east of and adjoining 915 23rd Street, as legally described, to the grantee, and for the consideration identified below, subject to a reservation of easements therein:

Grantee: Maria Rodriguez

Consideration: \$25.00

Legal Description: THE VACATED NORTH/SOUTH ALLEY RIGHT OF WAY LYING EAST OF AND ADJOINING LOTS 8 AND 9, -EXCEPT THE SOUTH 19.3 FEET THEREOF-, L. M. MANN’S SUBDIVISION, AN OFFICIAL PLAT, NOW FORMING A PART OF THE CITY OF DES MOINES, POLK COUNTY, IOWA, AND CONTAINING APPROXIMATELY 695 SQUARE FEET.

(VACATED BY ORDINANCE NO. 9,517)

2. A public hearing shall be held on November 15, 2021, at 5:00 p.m. in the City Council Chamber, City Hall, 400 Robert D. Ray Drive, Des Moines, Iowa. At that time the City Council will consider the above-described proposal and any other(s) submitted prior to or during the public hearing.
