AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, by amending Sections 114-1618, 114-1647 and 114-1692, relating to snow routes.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, by amending Sections 114-1618, 114-1647 and 114-1692, relating to snow routes, as follows:

Sec. 114-1618. Southeast Twenty-second Street.

Southeast Twenty-second Street, from Evergreen Avenue to Hartford Avenue.

Sec. 114-1647. Fiftieth Street.

Fiftieth Street, from Hickman Road to Urbandale Avenue.
Fiftieth Street, from Aurora Avenue to Madison Avenue.

Sec. 114-1692. Hartford Avenue.

Hartford Avenue, from South Union Street to Southeast Twenty-Second Street.

Section 2. This ordinance shall be in full force and effect from and after its passage and publication as provided by law.
