WHEREAS, the Security Information and Event Management (SIEM) Software Rapid 7 InsightIDR Subscription is being procured through the competitive bid process using the Omnia purchasing contract number 4400006644; and

WHEREAS, the Implementation Training is being procured via quote at market rate; and

WHEREAS, Municipal Code section 2-726 (m) provides for the procurement of goods and/or services from contracts that have been competitively established through cooperative group contracting consortiums for state government departments, institutions, agencies and political subdivisions, without conforming to the competitive bidding requirements of the Procurement Ordinance; and

WHEREAS, the Security Information and Event Management (SIEM) Software Rapid 7 InsightIDR Subscription is being purchased from Insight Public Sector, (Ken Lamneck, President and CEO, 6820 S Harl Ave, Tempe, AZ 85283), in the amount of \$147,213.14 utilizing the Omnia purchasing contract number 4400006644; and

WHEREAS, Implementation Training is being purchased from Insight Public Sector, (Ken Lamneck, President and CEO, 6820 S Harl Ave, Tempe, AZ 85283), in the amount of \$1,898.61, which is quoted at market rate; and

WHEREAS, funding is available from CIP FY2020-2021/FY2025-2026, MS001, C051IT, Enhanced Information and Communication System, page 33 in the amount of \$149,111.79.

NOW, THEREFORE, BE IT RESOLVED, that the City Council of the City of Des Moines, Iowa, accepts and approves the purchase of Security Information and Event Management (SIEM) Software Rapid 7 InsightIDR Subscription and Implementation Training in the amount of \$149,111.79 utilizing the Omnia purchasing contract number 4400006644.
