AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, by amending Sections 114-2052, 114-2235, 114-3235, 114-3461, 114-3744 and repealing Section 114-2056.05, relating to the use traffic and vehicle regulations.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, by Sections 114-2052, 114-2235, 114-3235, 114-3461, 114-3744 and repealing Section 114-2056.05, relating to the use traffic and vehicle regulations, as follows:

Sec. 114-2052. East Twenty-second Street.

East Twenty-second Street, at Ankeny Avenue, stop.

East Twenty-second Street, from the north line of Avenue Frederick M. Hubbell to the south line of Easton Boulevard, stop.

East Twenty-second Street, at East Jefferson Avenue, stop.

Sec. 114-2056.05. Repealed by Ord. No. -----.

Sec. 114-2235. Indiana Avenue.

Indiana Avenue, at Illinois Street, stop.

Indiana Avenue, at Maine Street, stop.

Indiana Avenue, from the west line of Second Avenue to the east line of Sixth Avenue, stop.

Indiana Avenue, at Eighth Street, stop.

Sec. 114-3235. East Glenwood Drive-Southeast Fourteenth Street to cul-de-sac east.

East Glenwood Drive, on the south side, from Southeast Fourteenth Street to Southeast Seventeenth Street, no parking any time.

East Glenwood Drive, on the north side, from Southeast Fourteenth Street to a point 75 feet east thereof, no parking any time.

East Glenwood Drive, on the north side, from a point 210 feet east of Southeast Fourteenth Street to appoint 25 feet east thereof, is designated a handicapped parking space and is subject to the same prohibition as is found in section 114-616(a) of this chapter.

Maple Street, on both sides, from East Fourteenth Street to a point 210 feet east of East Fifteenth Street, no parking any time.

Maple Street, on the south side, from a point 210 feet east of East Fifteenth Street to East Seventeenth Street, no parking any time.

Maple Street, on the south side, from East Eighteen Street to East Nineteenth Street, no parking any time.

Maple Street, on the north side, from East Eighteenth Street to a point 50 feet east thereof, no parking any time.

Maple Street, on the north side, from a point 195 feet east of East Eighteenth Street to a point 25 feet east thereof, is designated a handicapped parking space and is subject to the same prohibition as is found in section 114-616(a) of this chapter.
