

The improvement includes pavement scarification and Hot Mix Asphalt (HMA) overlay, Portland Cement Concrete (PCC) patching, PCC sidewalk, pavement markings, traffic signal modifications, and other incidental items; all in accordance with the contract documents, including Plans File Nos. 613-225/247, on E. 29th Street from Easton Boulevard to Euclid Avenue, Des Moines, Iowa
