## CONTINUANCE OF HEARING FOR VACATION OF A PORTION OF BIRDLAND PARK AND CONVEYANCE TO DES MOINES METROPOLITAN WASTEWATER RECLAMATION AUTHORITY (WRA) FOR THE WRA BIRDLAND PUMP STATION REPLACEMENT PROJECT

WHEREAS, the City of Des Moines is the owner of certain parkland located in Birdland Park, and lying south of and adjoining 1900 Saylor Road, Des Moines, Iowa ("Property"), upon which the City of Des (City) constructed a wastewater pump station and related conveyance facilities including a force main sanitary sewer and all related appurtenances thereto (collectively the "Improvements"); and

WHEREAS, the Des Moines Metropolitan Wastewater Reclamation Authority ("WRA") is a legal entity created for the purpose of conveying and treating wastewater from seventeen regional communities, and the City of Des Moines is one of the seventeen member communities that is a party to the Second Amended and Restated Agreement for the Des Moines Metropolitan Wastewater Reclamation Authority dated June 6, 2014, with an effective date of July 1, 2004 ("Agreement"); and

WHEREAS, the WRA plans to construct a replacement pump station ("Replacement Pump Station") near the location of the City's existing Birdland Pump Station; and

WHEREAS, the Agreement stipulated that the WRA may request such real property interest(s) as it needs to accomplish its public purposes from any participating community in relation to the construction, use, operation, maintenance, or other purpose of any improvements; and

**WHEREAS**, the WRA has requested the property interests necessary to construct the replacement WRA Birdland Pump Station; and

WHEREAS, once the Replacement Pump Station is fully constructed and fully operational and upon final acceptance by the WRA, the City's Improvements will be transferred to the WRA by virtue of a Bill of Sale to the WRA; and

WHEREAS, there is no known current or future public need for the Property proposed to be conveyed and the City will not be inconvenienced by the vacation and conveyance of said Property to the WRA; and

WHEREAS, in accordance with Iowa Code 364.7(3), the City proposes to convey the Property, except the Improvements, to the WRA at no cost for the public purpose of the WRA replacing the City of Des Moines Birdland Pump Station and taking over ownership and management of the wastewater pump station and related conveyance facilities including a force main sanitary sewer,
