ORDINANCE NO. _____

AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, by amending Sections 114-1 and 114-632, relating to trailers and trailers on public streets.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by

Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, by amending Sections 114-1

and 114-632, relating to trailers and trailers on public streets, as follows:

Sec. 114-1. Definitions.

The following words, terms and phrases, when used in this chapter, shall have the meanings ascribed to them in this section, except where the context clearly indicates a different meaning:

. . . .

Trailer means every vehicle without <u>non-motorizedive power device</u> designed for carrying persons or property, which vehicle is <u>and designed to be</u> drawn by a motor vehicle and is so constructed that no part of its weight rests upon the towing vehicle.

. . . .

Sec. 114-632. Residential districts.

- (a) No person shall park a motor truck, having a freight capacity greater than one ton or any trailer, semitrailer, tractor, road tractor or truck tractor unit having a freight capacity greater than one ton at any time upon any portion of a street abutting property zoned N-1 to N-5 or NX1 to NX3 occupancy, as defined in chapter 134 of this Code.
- (b) No person shall park a trailer, semitrailer, road tractor or truck tractor unit unattended and unattached to a vehicle at any time on any city street. This subsection shall not apply to trailers, semitrailers, road tractors or truck tractors parked on a city street abutting and for use at an active construction site between the hours of 7:00 a.m. and 10:00 p.m.
- (c) A person who violates any provision of this section shall pay a fine of \$100.00.

Section 2. This ordinance shall be in full force and effect from and after its passage and

publication as provided by law.
