## RESOLUTION REDEDICATING THE WEST TWO FEET OF $40^{TH}$ STREET BETWEEN INGERSOLL AVENUE AND GRAND AVENUE FOR RIGHT-OF-WAY PURPOSES

**WHEREAS**, Greenwood Park was originally platted in 1886 with Greenwood Lane, also known as 39<sup>th</sup> Street, and now known as 40<sup>th</sup> Street being sixty-six feet in width; and

**WHEREAS**, on June 23, 1902, the City Council of the City of Des Moines passed Ordinance No. 1169 vacating the west two feet of Greenwood Lane, also known as 39<sup>th</sup> Street, and now known as 40<sup>th</sup> Street between Ingersoll Avenue and Grand Avenue; and

WHEREAS, the vacated right-of-way was never transferred to the adjoining property owners as instructed in Ordinance No. 1169; and

**WHEREAS**, the previously vacated west two feet of 40<sup>th</sup> Street right-of-way between Ingersoll Avenue and Grand Avenue is now needed for roadway and pedestrian way purposes and requires rededication as public right-of-way.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa:

1. Previously vacated west two feet of 40<sup>th</sup> Street right-of-way between Ingersoll Avenue and Grand Avenue, legally described as follows, is hereby rededicated as public right-of-way.

THE VACATED WEST 2.0 FEET OF 40<sup>TH</sup> STREET LYING EAST OF AND ADJOINING LOT 9 OF GREENWOOD PARK, AN OFFICIAL PLAT, LYING SOUTH OF THE SOUTH RIGHT OF WAY OF INGERSOLL AVENUE AS PRESENTLY ESTABLISHED, AND LYING NORTH OF THE NORTH RIGHT OF WAY OF GRAND AVENUE, ALL NOW INCLUDED IN AND FORMING A PART OF THE CITY OF DES MOINES, POLK COUNTY, IOWA, AND CONTAINING APPROXIMATELY 1,166 SQUARE FEET.

- 2. The City Clerk is hereby authorized and directed to forward a certified copy of this resolution to the Real Estate Division.
- 3. The Real Estate Division is authorized and directed to forward the certified copy of this resolution to the Polk County Recorder for the purpose of causing said document to be recorded.
