ORDINANCE NO.	

AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, adding Sections 114-1544.05 and 114-1548.08 and amending Sections 114-2733, 114-2782, and 114-3292, relating to traffic and vehicle regulations.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, by adding Sections 114-1544.05 and 114-1548.08 and amending Sections 114-2733, 114-2782, and 114-3292, relating to traffic and vehicle regulations, as follows:

Sec. 114-1544.05. Keosauqua Way.

Keosauqua Way, on the southwest side, at a point 88 feet northwesterly of Oakridge Drive, pedestrian signal.

Sec. 114-1548.08. Sixth Avenue.

Sixth Avenue, on the west side, at a point 272 feet north of Crocker Street, pedestrian signal.

Sec. 114-2733. Southwest Twelfth Street-- Tuttle Street to Havens Avenue.

Southwest Twelfth Street, on the east side, from Tuttle Street to Gray's Parkway, no parking any time.

Southwest Twelfth Street, on the east side, from Davis Avenue to Elder Lane, no parking any time.

Southwest Twelfth Street, on the west side, from Davis Avenue to a point 50 feet north of Bell Avenue, no parking 7:00 a.m. to 6:00 p.m., Monday through Friday.

Southwest Twelfth Street, on the west side, from a point 50 feet north of Bell Avenue to a point 50 feet south of Bell Avenue, no parking any time.

Southwest Twelfth Street, on the west side, from a point 50 feet south of Bell Avenue to Watrous Avenue, no parking 7:00 a.m. to 6:00 p.m., Monday through Friday.

Southwest Twelfth Street, on the west side, from Watrous Avenue to a point 75 feet south thereof, no parking any time.

Southwest Twelfth Street, on the west side, from Elder Lane to a point 75 feet north thereof, no parking any time.

Southwest Twelfth Street, on the west side, from McKinley Avenue to Hackley Avenue, no parking any time.

Southwest Twelfth Street, on the east side, from Porter Avenue to Army Post Road, no parking any time.

Southwest Twelfth Street, on the west side, from Highview Drive to a point 50 feet south thereof, no parking any time.

Southwest Twelfth Street, on the west side, from a point 50 feet north of Payton Avenue to a point 50 feet south of Payton Avenue, no parking any time.

Southwest Twelfth Street, on the west side, from Leland Avenue to a point 70 feet south thereof, no parking any time.

Southwest Twelfth Street, on the west side, from Army Post Road to a point 50 feet north thereof, no parking any time.

Southwest Twelfth Street, on the west side, from Amos Avenue to Havens Avenue, no parking any time.

Sec. 114-2782. Eighteenth Street--Woodland Avenue to Hickman Road.

Eighteenth Street, on the east side, from Carpenter Avenue to Forest Avenue, no parking any time.

Eighteenth Street, on the west side, from a point 285 feet north of Clark Street to a point 25 feet north thereof, is designated a handicapped parking space and is subject to the same prohibition as is found in subsection 114-616(a) of this chapter.

Eighteenth Street, on the east side, from Clark Street to College Avenue, no parking any time.

Eighteenth Street, on the west side, from Franklin Avenue to Hickman Road, no parking any time.

Eighteenth Street, on the east side, from Hickman Road to a point 75 feet south thereof, no parking any time.

Sec. 114-3292. Hartford Avenue-South Union Street to East Watrous Avenue.

Hartford Avenue, on the south side, from South Union Street to a point 100 feet east thereof, no parking any time.

Hartford Avenue, on the south side, from a point 100 feet east of South Union Street to Indianola Avenue, no parking 7:00 a.m. to 6:00 p.m., Monday through Friday.

Hartford Avenue, on the south side, from Indianola Avenue to Southeast Third Street, no parking any time.

Hartford Avenue, on the north side, from South Union Street to a point 230 feet west of Southeast Sixth Street, no parking any time.

Hartford Avenue, on the north side, from Southeast Sixth Street to a point 100 feet east, no parking any time.

Hartford Avenue, on the north side, from a point 180 feet west of Southeast Eighth Court to a point 130 feet east of Southeast Eighth Court, no parking any time.

Hartford Avenue, on the south side, from a point 150 feet west of Southeast Fifth Street to a point 50 feet east of Southeast Fourteenth Street, no parking any time.

Hartford Avenue, on the north side, from a point 230 feet west of Southeast Fourteenth Street to a point 50 feet east of Southeast Fourteenth Street, no parking any time.

Hartford Avenue, on the north side, from Southeast Fourteenth Street to a point 50 feet east thereof, no parking any time.

Hartford Avenue, on the south side, from Southeast Fourteenth Street to a point 50 feet east thereof, no parking any time.

Hartford Avenue, on both sides, from Southeast Eighteenth Street to Southeast Twenty-second Street, no parking any time.

Section 2. This ordinance shall be in full force and effect from and after its passage and publication as provided by law.
