HOLD HEARING FOR APPROVAL OF DOCUMENTS FOR VACATION OF EXCESS CITY RIGHT-OF-WAY LOCATED NORTH OF AND ADJOINING 4225 NORTHWEST DRIVE AND CONVEYANCE TO GABRIEL CONCHA AND MARIYA VELICHKOVA CONCHA FOR \$100

WHEREAS, Gabriel Concha and Mariya Velichkova Concha, owners of 4225 Northwest Drive, Des Moines, have requested the vacation and conveyance of a portion of the east-west alley right-of-way lying north of and adjoining their property, which request was not presented to the City's Plan and Zoning Commission for review and has instead been determined by the City Traffic Engineer to have no significant impact upon the public use of the right-of-way, in accordance with Municipal Code 102-286(b); and

WHEREAS, Gabriel Concha and Mariya Velichkova Concha have offered to the City of Des Moines, Iowa ("City") the purchase price of \$100.00 for the purchase of the portion of east-west alley right-of-way lying north of and adjoining 4225 Northwest Drive for incorporation into their adjoining property for, expanded rear yard, subject to the reservation of easements for all existing utilities in place, until such time that they are abandoned or relocated, and further subject to the reservation of a permanent no-build easement upon, over and within the property, which easement will be contained in the quit claim deed from City to Buyer, which price reflects the fair market value of the alley right-of-way as determined by the City's Real Estate Division; and

WHEREAS, there is no known current or future public need for the alley right-of-way proposed to be vacated and sold, and the City will not be inconvenienced by the vacation and sale of said property.

WHEREAS, on May 9, 2022, by Roll Call No. 22-0692, it was duly resolved by the City Council of the City of Des Moines, Iowa, that the proposed vacation and conveyance of the alley right-of-way be set for hearing on May 23, 2022, at 5:00 p.m., in the City Council Chambers, City Hall, 400 Robert D. Ray Drive, Des Moines, Iowa; and

WHEREAS, due notice of said proposal to vacate and convey the alley right-of-way was given as provided by law, setting forth the time and place for hearing on said proposal; and

WHEREAS, in accordance with City Council direction, those interested in the proposed vacation and conveyance, both for and against, have been given an opportunity to be heard with respect thereto and have presented their views to the City Council.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, as follows:

1. Upon due consideration of the facts and statements of interested persons, any and all objections to the proposed vacation and conveyance of the portion of east-west alley right-of-way lying north of and adjoining 4225 Northwest Drive, as described herein, are hereby overruled and the hearing is closed.
