REALLOCATION OF EMERGENCY SOLUTIONS GRANT (ESG), INCLUDING COVID-19 RESPONSE FUNDS (ESG-CV), FUNDING FROM THE US DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT (HUD)

WHEREAS, on November 30, 2018, the City received several applications and requests for Emergency Solutions Grant (ESG) funding under the U.S. Department of Housing and Urban Development (HUD) for program years 2019 and 2020; and

WHEREAS, on February 25, 2019, by Roll Call No. 19-0290, the Council approved ESG funding allocations to five subrecipients, including:

- Hawthorn Hill,
- Central Iowa Shelter & Services,
- Iowa Homeless Youth Center,
- Primary Health Care (PHC), and
- Iowa Institute for Community Alliances; and

WHEREAS, on August 3, 2020, by Roll Call No. 20-1224, the Council approved a continuation of the 2019 allocations with the 2020 ESG funding to the aforementioned five subrecipients; and

WHEREAS, on March 7, 2022, by Roll Call No. 22-0334, the Council approved reallocation of \$50,000 in ESG funds from program year 2020 to Hawthorn Hill; and

WHEREAS, PHC has an additional \$4,001.75 it will not be able to spend by the extended deadline; and

WHEREAS, on January 25, 2021, by Roll Call No. 21-0105, the Council approved a second round of ESG-CV funding allocations to five subrecipients, including:

- Home Opportunities Made Easy, Incorporated (HOME, Inc.),
- Central Iowa Shelter & Services,
- Anawim,
- Primary Health Care (PHC), and
- Iowa Institute for Community Alliances; and

WHEREAS, HOME, Inc. has voluntarily returned \$12,206.09 in ESG-CV 2 funds to the City; and

WHEREAS, on May 13, 2022, HUD notified the City of its 2022 allocations for the Office of Community Planning and Development (CPD) formula programs, of which the ESG allocation was \$326,842, an increase of \$3,022.00 from the 2021 allocation; and

WHEREAS, subrecipients Hawthorn Hill and Anawim have expressed interest in and ability to expend reallocated funds from the ESG or ESG-CV 2 programs.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that the following recommendations regarding the utilization of ESG and ESG-CV 2 funding are hereby approved:
