RESOLUTION APPROVING ISSUANCE OF PARTIAL CERTIFICATE OF COMPLETION TO 13TH & MULBERRY, LLC, FOR HISTORIC RENOVATION AND REDEVELOPMENT OF A BUILDING LOCATED AT 213 13TH STREET

WHEREAS, on December 21, 2020, by Roll Call No. 20-2118, the City Council approved an Urban Renewal Development Agreement for the historic renovation and redevelopment of the existing one-story, historic building on the Phase 1 Property, locally known as 213 13th Street and formerly known as the Iowa Ford Tractor Company building originally constructed in 1949, in conformance with an approved Conceptual Development Plan; and,

WHEREAS, the Phase 1 Improvements have been completed in substantial compliance with the Development Agreement and the approved Conceptual Development Plan; and,

WHEREAS, 13th & Mulberry, LLC has requested that the City issue a Partial Certificate of Completion as evidence of the satisfaction of its construction obligations under Phase 1 of the Agreement.

NOW THEREFORE, BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, as follows:

1. The City Council hereby finds and acknowledges that as of December 9, 2021, 13th & Mulberry, LLC has satisfied its obligation to complete the Phase 1 Improvements at 213 13th Street, Des Moines, Iowa, more specifically described as:

Lot 5 (Except the North 12 feet) and all Lot 6, in Block 29, in Keene & Poindexter's Addition to Fort Des Moines, an Official Plat, City of Des Moines, Iowa. (TPN: 020/01664-001-000); also described as: Lots 5 and Lot 6 in Block 29 in Keene & Poindexter's Addition to Fort Des Moines, an Official Plat, now included in and forming a part of the City of Des Moines, Polk County, Iowa.

in substantial compliance with Phase 1 of the Urban Renewal Development Agreement with 13th & Mulberry, LLC and the approved Conceptual Development Plan. This resolution shall serve as the Partial Certificate of Completion to be issued by the City pursuant to Section 2.4 of that Agreement.
