AN ORDINANCE vacating the east-west alley right-of-way located south of and adjoining 2512 Woodland Avenue.

WHEREAS, all prior requirements of law pertaining to the vacation of public right-of-way have been fully observed; and

WHEREAS, it is desirable that the public right-of-way herein described be vacated;

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Des Moines, Iowa:

Sec. 1. That the east-west alley right-of-way located south of and adjoining 2512 Woodland Avenue, more specifically described as follows, be and is hereby vacated:
