## RESOLUTION APPROVING PURCHASE OF CITYWIDE CELLULAR VOICE, DATA AND RELATED PRODUCTS, AND APPROVING USE OF STATE OF IOWA (DAS) MASTER AGREEMENT #22358, AND APPROVING AGREEMENT WITH US CELLULAR CORPORATION

**WHEREAS**, the Information Technology Department has requested the Finance Department's Procurement Division to procure City-wide cellular voice, data, and related products; and

**WHEREAS**, the Procurement Administrator has determined that the purchase of City-wide cellular voice, data, and related products has been competitively bid and is available from US Cellular Corporation (Laurent Therivel, President and CEO, 8410 W Bryn Mawr, Chicago, IL 60631), per the State of Iowa (DAS) Master Agreement #22358; and

**WHEREAS**, the State of Iowa (DAS) Master Agreement #22358 has a term expiring June 30, 2025, with optional one-year renewals; and

**WHEREAS**, Des Moines Municipal Code Section 2-726(k) provides for the procurement of goods and/or services from supply schedules established by the State of Iowa Department of Administrative Services (DAS), without conforming to the competitive bidding requirements of the Procurement Ordinance; and


**WHEREAS**, said purchase may require a Short Form Agreement between the City and US Cellular Corporation, supplementing said State Contract, with terms specific to the City's procurement, with said agreement to be negotiated by the City's Finance and Information Technology Departments; and

**WHEREAS**, funding for said procurement in the estimated annual amount of \$300,000.00 is available from various City department operating budgets.

**NOW, THEREFORE, BE IT RESOLVED**, by the City Council of the City of Des Moines, Iowa, that:

- 1. The purchase of City-wide cellular voice, data, and related products from US Cellular Corporation, in the estimated annual amount of \$300,000.00, and using the State Contract is hereby approved through June 30, 2025.
- 2. To the extent determined necessary by the Legal Department and the Finance Department, the Finance Department and Information Technology Departments are hereby authorized and directed to proceed with negotiation of a Short Form Agreement or similar agreement between the City and US Cellular Corporation, supplementing State of Iowa Master Agreement #22358, and the Finance Director is authorized and directed to execute said Agreement on behalf of the City following approval as to form by the Legal Department.
