Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. Article VI of Section 82 of the Municipal Code of the City of Des Moines, 2000, code sections 82-246 - 82-275 be and the same are hereby deleted in their entirety as follows:

Section 4. Section 90-31(b) of the Municipal Code of the City of Des Moines, 2000, be

and the same is hereby amended as follows:

Chapter 90 – Public Housing Article II – Housing Services Board Section 90-31(b) - Established

(b) The board shall consist of twelve members, each having the right to vote. The mayor and each council person shall appoint one member of the board. The mayor shall appoint one additional member from the neighborhood revitalization board and one additional member from the Polk County Housing Continuum or an individual performing one of the functions below who shall be confirmed as provided in section (d) below. All appointments shall be for three years, provided, however, that each member shall hold over until his or her successor is appointed and confirmed. Any vacancies occurring in the membership shall be filled in accordance with sections 2-1046 and 2-1047 of this Code. Any member may be removed by a majority vote of the city council. The terms of board members shall expire on June 30 of the year in which their terms expire. All appointments after the original appointments shall be in accordance with sections 2-1046 and 2-1047 of this Code.

Section 5. Section 82-278(d) of the Municipal Code of the City of Des Moines, 2000, be, and the same is hereby amended as follows:

Chapter 82 – Planning Article VII – Strategic Planning Commission Section 82-278(d) – Qualifications and nominations

Sec. 82-278. - Qualifications and nominations.

- (a) The strategic planning commission shall have 19 members. All nominations to the strategic planning commission are subject to confirmation by the city council.
- (b) The mayor and council members shall each nominate one member to the commission.
- (c) The airport authority board, plan and zoning commission, park and recreation board, urban design review board and board of trustees of the library shall each nominate one of their members to be a member of the commission.
- (d) The neighborhood revitalization board shall nominate two of its members to be members of the commission. The board shall nominate one of its members who was appointed to represent the interests of the residential neighborhoods of the city, and shall nominate one of its members who was appointed to represent the interests of low and moderate income residents of the city.
- (e)(d) Downtown Partnership, Inc., may nominate one of the members of its board or staff to be a member of the commission.
- (f)(e) Des Moines Neighbors may nominate one of the members of its executive committee to be a member of the commission.

- (g)(f) Polk-Des Moines Taxpayers Association may nominate one of the members of its board or staff to be a member of the commission.
- (h)(g) The Des Moines Independent School District may nominate one of the members of its board or staff to be a member of the commission.
- (i)(h) The county board of supervisors may nominate one of the members of its board or staff to be a member of the commission. Such member is exempt from the residency requirement in section 2-1049 of this Code.

Section 6. This ordinance shall be in full force and effect from and after the later of its passage and publication as provided by law.
