## ORDINANCE NO.

AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, by amending Section 114-2665, relating to traffic and vehicle regulations.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by

Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, by amending Section 114-

2665, relating to traffic and vehicle regulations, as follows:

## Sec. 114-2665. Seventh Street--Grand Avenue to High Street.

Seventh Street, on the east side, from Grand Avenue to a point 46 feet north thereof, no parking any time.

Seventh Street, on the east side, from a point 46 feet north of Grand Avenue to a point 46 feet north thereof, no parking 4:00 p.m. to 9:00 a.m.

Seventh Street, on the east side, from a point 92 feet north of Grand Avenue to High Street, no parking any time.

Seventh Street, on the west side, from Grand Avenue to High Street to a point 120 feet south thereof, no parking any time.

Section 2. This ordinance shall be in full force and effect from and after its passage and

publication as provided by law.
