**APPROVING PROCUREMENT OF CISCO IE4000 NETWORK HARDWARE FOR INTELLIGENT TRANSPORTATION SYSTEMS FROM HEARTLAND BUSINESS SYSTEMS PER THE STATE OF IOWA CONTRACT NO. 21294 AND NASPO VALUEPOINT CONTRACT NO. AR3227**

**WHEREAS**, the Information Technology Department has requested the Finance Department’s Procurement Division issue a purchase order for the purchase of Cisco IE4000 network hardware for intelligent transportation systems; and

**WHEREAS**, the Cisco IE4000 Hardware is being procured through the competitive bid process using the State of Iowa Department of Administrative Services (DAS) purchasing contract no. 21294 and NASPO ValuePoint contract no. AR3227; and

**WHEREAS**, Des Moines Municipal Code Section 2-726(k) provides for the procurement of goods and/or services from supply schedules established by the State of Iowa Department of Administrative Services (DAS) without conforming to the competitive bidding requirements of the Procurement Ordinance; and

**WHEREAS**, the Cisco IE4000 Hardware is being purchased from Heartland Business Systems, (Peter Helander, CEO, 108 3rd Street, Suite 300, Des Moines, Iowa 50309), in the amount of \$396,113.60; and

**WHEREAS**, funding is available from FY2020-2021/FY2025-2026, TR097, C038EG99, Traffic System Operation Improvements, G.O. Bonds, Page Street – 164.

**NOW, THEREFORE, BE IT RESOLVED**, that the City Council of the City of Des Moines, Iowa, hereby accepts and approves the purchase of Cisco IE4000 network hardware for intelligent transportation systems from Heartland Business Systems in the total amount of \$396,113.60, using State of Iowa Department of Administrative Services (DAS) purchasing contract no. 21294 and NASPO ValuePoint contract no. AR3227, and directs the Finance Department, Procurement Division to issue a purchase order for said goods and at said total amount pursuant to the terms of said DAS contract.
